ADDITIONAL NARRATIVE

Jerry Linsner. She explained that at the time she was drinking alot and that Dr Knack recommended treatment at the Silver House in Connecticut. After she got out of treatment she started to see Dr Knack as a patient in 2011. While seeing him in 2011 she stated that he started to hug her and one time grabbed her buttocks so hard that he left a bruise. This would happen inside his office in Chappaqua. When she would see him she stated that he would have her leave her purse and jacket outside of his office in the waiting area. She stated that Dr Knack practices out of his house and that he is alone in the office with no one working but him at the office. She stated that Dr Knack would start off by hugging her and make comments about what she was wearing and her body. She would see him twice a week and always wanted a hug and always wanted to see her and would be angry if she didn't come and see him. He would tell her when he was angry that maybe he should send her back to silver house which would scare her. She also described some incidents during this time that Dr Knack would dropped his pants and would want oral sex. When I asked he ever made her perform oral sex on him she stated no that it didn't happen but he tried and would stop when she wouldn't. She stated that he has a mole on right thigh. She explained that Dr Knack would always say he was sorry after each incident.. She also stated that he would make comments, like his irish sausage, he would always hug her, would kiss and even bit her once, she stated that when she would see him she would sit on the couch and he would sit right next to her

In 2012 she stated that Dr Knack wasn't charging her for her therapy sessions. During the interview Ms Feldman was very upset and emotional. I asked her if anything else happened to her other than what she was telling me and she said no. She did tell me that she has spoken to Dr Shander her current therapist about what happened and that she helped her write Dr Knack an e-mail confronting him about what happened. She stated that the last time she saw Dr Knack was November of 2013 and when she left the office and while she was driving home she threw up because she was so upset. I asked if she had a copy of the e-mail and she said yes and that she could e-mail me a copy. She explained that Dr Knack never responded to the e-mail and that she has not heard from him since. I told her that I would need to see her again and asked if she had any record of dates when she would have seen him at his office. She stated that she would look.

I did contact her a couple of days later and asked if she had a copy of the e-mail. she stated that she did and was able to find it and she did e-mail me a copy. The e-mail was sent on November 14 2013 to Dr Knack at Knackw@oldwesttbury.edu the e-mail states that she wanted to let Dr Knack know that she will not be coming back to therapy anymore with him. She states that his sexual acting out with her was absolutely not acceptable. She writes about him hugging her so hard that he left bruises, kissing her while they were on the couch, and commenting on her clothes and body when she came into his office. She then writes that she threw up all the way home the last time he did it. She states that she trusted him and that he violated that trust and crossed the line of therapy. Dr Knack did not respond back to this email.

While I spoke with Ms Feldman I asked if I could reach out and speak with Dr Shander about what happened and she stated yes and provided her office number to me. I did make several attempts to contact her and left several messages that she did not return.

On April 21 2014 I did make contact with Ms Feldman. When I called she was very

upset over what happened to her with Dr Knack. She stated that she was moving and having a hard time right now with her ex-husband that he was making her move. She stated that she couldn't talk right now. She then stated that she had been raped by Dr Knack and couldn't tell me because she was so up set and embarrassed and did n';t know how to tell me. She stated that she didn't want to talk right now but would call me when she was ready. I asked her if she had found her calendar with dates that she have seen Dr Knack and she explained that she would look.

May 27 2014 I contacted Ms Feldman after not hearing from her. She stated that she was having a bad day and I asked if she found the calendar. She stated she would look and I told her that I would like to talk with her what what happened or if she felt more comfortable with a women I could make arrangements for a women to speak with about what happened. She stated that that would be batter so I explained that I would contact her with with that information. After speaking with Ms Feldman I tried calling Dr Shander once more. When I called she answered the phone and I spoke with her about Ms Feldman. I asked her if she knew what happed with Ms Feldman and Dr Knack and she stated yes that Ms feldman had told her about inappropriate touching by Dr Knack and she stated yes. I then asked if she ever told her anything about Dr Knack raping her and she stated no that Ms Feldman never told her anything about being raped. Dr Shander then wouldn't discuss Ms feldman anymore and ended the call.

After speaking with Dr Shander I contacted the Westchester County District Attorneys Office and spoke with ADA Heidi Mason. I explained the case and she agreed to meet with Ms Feldman and interview her. I then made contact with Ms Feldman about meeting a women at the District ATtorneys office and she agreed to meet with her and stated she was available all week.

On June 4 2014 Ms Feldman met myself and Det Vargas at the Police Department and we drove her down to the District Attorneys Office in White Plains. Ms Feldman was interviewed by ADA lopez in her office regarding the case. Myself and Det Vargas were not present during the interview.

After the interview I spoke with Ms Feldman about during a controlled phone call to Dr Knack. She stated that she would be willing to make the call and wanted to help with the case. I advised her that I would be in contact with her about setting up the call to Dr Knack.

06/18/2014 R/Sgt met with Ms Feldman inside the interview room of the Detectives. Ms Feldman was going to place a call to Dr Knacks cell phone which was going to be recorded. She did sign a letter consenting to the recording of the call. At 11 am she placed the call to his cell phone 914-874-3455 from her cell phone. I was using a digital recorded with a ear piece that records the conversation. She did make the call and did have a brief discussion with Dr Knack. He was busy and the conversation was short. The call ended and we spoke about making another call to Dr Knack. I stated that I would be in contact to set up a date for the call. The call was down loaded onto a disk and saved.

07/17/2014 I met with Ms feldman inside the interview room of the Detectives. She was planning and making a second call to Dr Knack regarding the above case. At 1:13pm she placed a call to Dr Knack on his cell phone 914-874-3455 when she made to call the same digital recorder was used. Dr Knack did answer the call and did speak with Ms feldman on the phone. Ms feldman was very upset on the phone and was telling Dr Knack how could he have done this. The call lasted

several minutes. After the call ended Ms Feldman stated that Dr Knack said that he was sorry several times that he cared for her. I advised her that I would listen to call and would be in contact.

07/18/2014 I did listen to call on the recorder. The first couple of minutes of the call is very hard to hear Dr Knack on the phone. After a couple of minutes you can then clearly hear Dr Knack on the phone. Dr Knack states several times that he is sorry. He stated that he cared for her. The call was down loaded onto a disk and saved. I listened again and still the first couple of minutes of the call it is very hard to hear Dr Knack side of the conversation. After a couple of minutes you can then clearly hear Dr Knack.

I did speak with Ms Feldman she had called regarding the case. I explained that I wanted to listen again and that it was hard to hear Dr Knack in the first part of the recording. I also stated that I would touch base with the District Attorneys Office regarding the case.

I did contact ADA Lopez regarding the case. We disused the case and I advised her of the controlled phone calls. She stated that there was a problem with case since Ms Feldman was still seeing Dr Knack as a patient after the date of the above rape. She stated that she would speak with someone in her Office and would contact this detective next week.

Det Vargas did speak with ADA Lopez regarding the above case. The case could not foreword with the information that we had.

08/13/2014 at about 11:03 am I attempted to speak with Dr Knack regarding the above case. I left a message on his cell phone.

08/15/2014 11:57 am I received a call from Dr Knack. He was returning my phone call from Aug 13. I asked if I could meet with him and speak to him. He asked what it was about and I stated that I wanted to speak with him about one of his patients. I then stated I wanted to speak with him about Ms Feldman. He stated that he was not allowed to speak about his patients and wouldn't confirm that Ms Feldman was a patient in the past. He stated that he would be able to speak with this detective. The call was then ended.

I was then later contacted by an attorney David Squirell who advised that Dr Knack had contacted him about my call. I advised that I wanted to speak with Dr Knack about a past patient of his. He stated that he would speak with Dr Knack and contact this Detective.

I did later receive a call back from Mr Squirell who advised that Dr Knack would not be talking with this detective.

I was contacted by an attorney John Hannigan who was retained by Ms Feldman after I had advised her that there were no criminal charges. He asked about the case and I advised him that there was not enough evidence to proceed with criminal charges. He asked about the phone recordings and asked that they be preserved. I advised that they were part of the case. I also advised him of the problem with the one recording where it is hard to hear the voice of DR knack in

the first half of the call. He asked if he could listen to the calls and he did

Jan 15 2015 The Department received a letter from Attorney Peter Harrington who is represents Ms Feldman in a law suit against Dr Knack. He was requesting copies of the recorded phone conversations. The letter was also signed by Ms Feldman giving the consent of the release of the recorded calls. Copies were made of the calls and were given to a Stephen Mazzi an employee of the firm on Jan 21 2015
